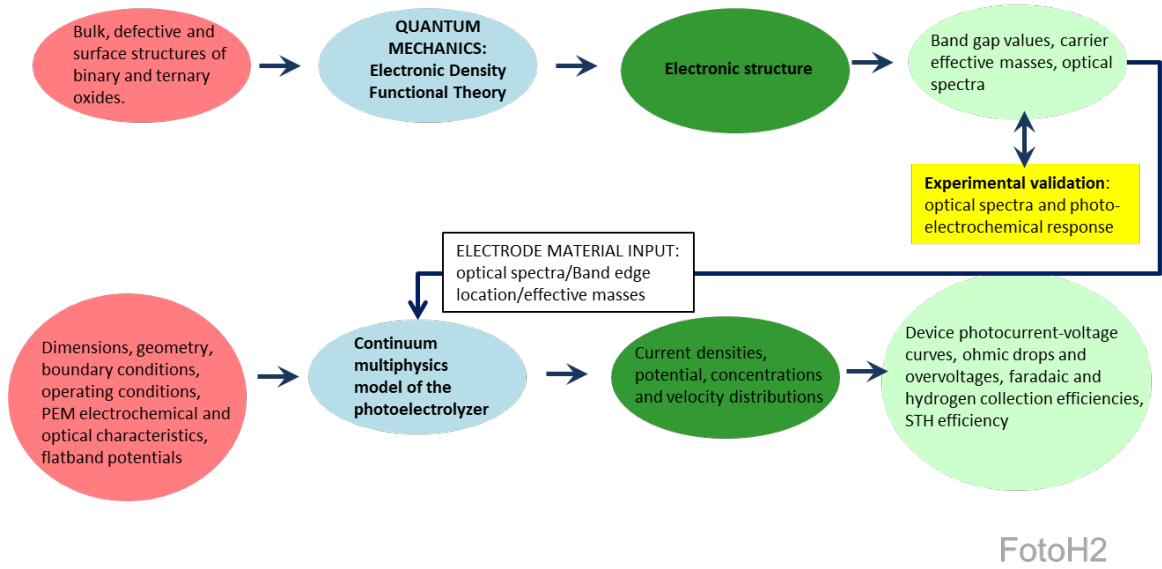

4	Access conditions	<p>The program Vienna Ab Initio Simulation Package (VASP) is commercially distributed by the University of Wien (www.vasp.at). For the simulations of the continuum model commercial software COMSOL (www.comsol.com) and/or ANSYS (FLUENT) (www.ansys.com) will be employed. The use of the open source CFD software OpenFoam (www.openfoam.com) is not discarded. The models and post-processed data will be distributed among project partners. External user may be given access upon contacting the owners (partners contributing to the development of the models) and after approval by the consortium.</p>	
5	Workflow and its rationale	<p>As workflow, in model 1, activities will regard the application of the density functional theory to binary and ternary oxide semiconductor materials. This analysis focusses on the optoelectronic properties of pure and doped oxides.</p> <p>Model 2 will apply a continuum approach to obtain relevant parameters of the photo-electrochemical device (cell design, fluid dynamics, heat exchange, reaction rates etc.). The rationale is discussed below:</p> <p>The user case demands a continuum model that comprises conservation of species and charge, transport phenomena, and electrochemical thermodynamics and kinetics. For most of the macroscopic properties, materials relations and data are available. The key elements in the device are the photoelectrodes that act as light absorbers and sustain the electrochemical reactions. Electronic structure (and particularly corresponding optical properties) determine to a great extent the behaviour of the electrode materials. Related literature data for ternary oxides is scarce and thus model 1 should provide valuable input for model 2. Model 1 aims at screening different semiconductor ternary oxides for selecting candidate materials with convenient electronic properties for the intended application. Density Functional Theory (DFT) calculation methodologies will provide a convenient means for obtaining band structure information of oxide semiconductors, leading to estimation of their electronic and optical properties.</p>

4 POST PROCESSING		
4.1	The processed output	Device photocurrent-voltage curves, ohmic drops and overvoltages, faradaic and hydrogen collection efficiencies, STH efficiency.

4.2	Methodologies	For the obtainment of the device photocurrent-voltage curves, ohmic drops and overvoltages, current densities and potentials are averaged over the corresponding surface area.
4.3	Margin Of Error	20-30% as a result of model assumptions and the existence of discretization and linearization errors.
